WITHDRAWALS

If you wish to withdraw at the end of the month, written notice must be received at least two weeks prior to your last class in the month. If you wish to withdraw at any other time of the month, written notice must be received a minimum of four weeks prior to your last class. Understand that once a withdrawal form is submitted it cannot be rescinded. If you withdraw after a billing cycle there will be no refunds but a credit can be placed on your account. REFUNDS OR CREDITS

Smilefish Swim School will not offer tuition refunds for any reason. However, if a class is cancelled due to facility closure or weather closure a credit will be placed on your account and will be applied to your next monthly billing cycle. If a participant is withdrawn the credit will be carried forward to a future time. Credits will be kept on the books for one year. Credits cannot be transferred to other parties, nor can they be converted to cash.
